

#### FORM OF CONTRACT AGREEMENT

THIS AGREEMENT made on the day of October 2022, between Municipal Committee, Muridke (hereinafter "the Employer"), of the one part, and M/s Choudary Enterprises (hereinafter called "the Contractor"), of the other part:

WHEREAS the Bid has been accepted by the Employer for a Contract Cost of Pak Rs. 25,58,21,790/- (Twenty Five Crore, Fifty Eight Lac, Twenty One Thousand, Seven Hundred and Ninety only) for construction and completion of "IMPROVEMENT AND CONSTRUCTION OF ROADS MC MURIDKE" and the remedying of any defects therein.

NOW this agreement witnesseth as follows:

- In this Agreement words and expression shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- (j) The Specifications.
- 3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects with the provisions of the Contract.
- 4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
